**2019 Spring Field Trip – May 3 – 5**  
**Susquehanna & Tidewater Canals**

**Headquarters: Comfort Inn & Suites, 1 Center Drive, North East, MD 21901** - Interstate 95 Exit 100, **410-287-7100** and use our group code **sj01m7** (that's a zero, not letter O). Remember to make your own hotel room reservations separately as they are not part of the tour registration. Be sure to mention our group code above in order to secure our special rate of \$99 (plus tax) per night. Reservations should be made by 5:00 PM on April 19, 2019. **Saturday Tour:** For our lower Susquehanna trip we'll first head up to PA Dutch country to Susquehanna Lock 12 and 13 and the limestone kiln and other features there, followed by a short drive to Lock 15. From there we'll head into Maryland and the realm of the Tidewater Canal. We'll first visit one of the older Maryland Susquehanna Canal Locks at Octoraro Creek just below Conowingo Dam, completed in 1805, and then stop at the visitor center where we'll have lunch.

Our next stop at will be the Rock Run Grist Mill, barn, spring house, and mansion in Susquehanna State Park. Here we'll get a good view of the canal prism and an opportunity to walk the towpath which has the remains of a railroad used to build the Conowingo Dam. Along the towpath is a toll house for what was, until 1865, one of the longest covered bridges in the U.S. A short drive takes us down to remains of Lock 8 at Lapidum and the partial remains of an outlet lock to cross over to Port Deposit. Our final stop is the restored outlet lock, Lock 9 at Havre de Grace, and a visit to the Lock House Museum.
